# A different format AGM for us this year

Hello members,

This year's AGM on **November 26th** will be different due to COVID-19.0. We will be hosting our AGM using Zoom video conferencing. A minimum of 37 members participating are required to conduct AGM business. Our goal is to accommodate everyone that would like to participate so an advanced survey was sent out to determine how people planned on attending. Most respondents indicated that they will be using a computer or tablet. Phone users may have some issues following along but we will do our best to make the conference work for them as well.

The other new item this year is that we are giving members an opportunity to submit questions in advance via email to secretary@bqyc.ca. This will give the board an opportunity to prepare responses and will help us manage the dynamics of the video conference. We will still have the regular opportunity to ask questions during the meeting and make modifications to motions.

Voting on motions will be done using an **online polling system** that is part of Zoom. The polls will be structured to allow 2 members to vote from a single zoom session (see example below). If only one member is attending the call via zoom only the first multiple choice should be answered prior to pressing the submit button.

Fridays continue to be the most popular night at BQYC so get there early if you like to sit at a special table.


Saturday pool has resumed. Alex Waywell has worked with the board to create COVID-19 compliant pool table playing rules. The pool table is available to use on Saturday's only.



## **BQYC Pool Table COVID-18 Policy**

- Pool table usage will be on Saturday afternoons only.
- Games are to be limited to 2 players at a time to reduce congestion at the table
- Masks must be worn at all times when not seated at a table as per club indoor policy.
- Players must sanitize hands prior to playing and also when finished the game
- 5) Players must not return to their table for food or drink once they have started a game. This is to limit the number of times masks are taken on and off and reduces risk of face and food contamination with the playing surface.
- 6) Members are suggested to bring their own cue. If using a club cue, the player is to wipe the cue down before and after with wipes provided at the rack
- 7) Players are to be mindful of members needing to pass by the pool table for lounge access.

# **Quinte Sailability**




Quinte SailAbility has successfully moved their operations to BQYC.
