Visitors dock for September

This year, due to Covid-19, most of our visiting boats were from Toronto yacht clubs. One exception was a 41' yacht enroute from the Bahamas to Toronto. Boats ranged in length from 25' to 47'. Most were 32' plus. Coincidentally, this year's longest visiting yacht now holds the record for the longest layover on the rocks hidden beneath "the beautiful blue waters of the Bay of Quinte" located between the red navigation aid and East Zwicks. It took the combined power of her own engine plus two rescue vessels to move her (displacement 34,000 lbs.) into deeper water. To highlight this event, the longest yacht with the longest layover was conspicuously escorted to our visitors' dock by Quinte Rescue and the OPP. The widest boat (19.5') was *RAIN*, a 37' catamaran owned by **Fiona McCall** and **Paul Howard**.

Fiona and Paul made a presentation to our membership in the early 1990's regarding their circumnavigation of the world (1983-1988) aboard their 30' steel junked-rigged sailboat *LORCHA*. They were accompanied by their two children, Penny age 6 and Peter age 4. It was very special to have Paul and Fiona here.

Our visitors didn't mind being relegated to the outdoors. Some mingled with us on the Patio, some preferred the Upper Deck, and all were welcomed into the Red Chair Circle of Wisdom on the front lawn. All had a story to tell. The one that I liked best was the admission by one grandfather that he smuggles ice cream aboard for his grandson.

Short boating season for our visitors. Super visitors. Super BQYC volunteer dock 'boys and girls' including Michael, Dale, Alex, Maryise, and others.

Going into Fall

Hello members,

We have reconfigured the club to allow indoor seating starting Monday September 14th. We have capacity for 21 people in the bar area and another 12 seats in the dining room area. The outdoor seating area will remain open. The tables and chairs have been positioned to meet the 2m required distance and must not be moved from their current placement. Table seating positions marked with an X can not be used. The pool table remains closed.

When you enter the club you must wear a mask. The cloakroom is closed so bring your jacket with you to the table. Follow the direction arrows marked on the floor. When you decide where you would like to sit look for a green clean card on the table. This indicates that it has been sanitized and is ready to be used. Once you are seated you can remove your mask. The bartender will take your order and deliver the food and drinks to your table. If you leave the table you must put your mask back on.

Once you are done for the evening:

put on your mask, leave used glassware on the table, flip the green card over so the red side is showing. The bartenders and other members will know that the table needs to be cleaned before someone new uses it proceed to the bar to settle up for the night.

Key Points to remember:

- 1) Masks must be worn by anyone in the club who is not seated at a table.
- 2) Tables and chairs must not be moved from their current placement.
- 3) The bartenders will continue to provide table service. Food and drink can not be picked up at the bar.
- 4) Food and drink can only be consumed while seated at a table.
- 5) When you are done leave the dirty glassware on the table and flip over the clean indicator card.

Almost everyone who has entered our facility is trying their best to follow the rules. Thankyou for your support and understanding. We acknowledge that change is difficult and that many of you have developed meaningful relationships and a sense of comfort and familiarity when at the club. A desire to connect has led to some complacency with regards to the new rules such as walking about the bar without masks, not being seated while drinking and tables beyond the seating capacity with members standing and drinking. Unfortunately these actions put the club at risk of serious fines, closure and most importantly an increased risk of COVID-19 transmission.

The province has clearly stated that all customers must be seated when eating or drinking at the establishment. (Ontario Reopening FAQ)

To help with the challenges we added two large round tables each with 6 chairs in the east end of the dining room. If you are meeting up with your cohort and there are more than four people please use these tables.

COMPLIANCE

We must do our part to keep our community safe.

Effective immediately, members who are not seated at a table will not be served. Members seen walking around without a mask on will be reminded that masks must be worn. Members drinking while standing will be reminded to find a place to sit. If the member is non-compliant with the reminders, no further drink service will be offered for that evening and an incident report will be filed with me as acting bar director for follow up. Please raise any concern regarding the new rules with me or other board directors rather than the bar tenders. Please support each other, our bartenders and the board of directors as we try to keep our club safe for the use of all members this fall and winter.

Rules for Indoor Club Use:

- 1) If you don't feel well, please stay home
- 2) Masks must be worn by anyone inside the club who is not seated at a table.
- 3) Tables and chairs must not be moved from their current placement.
- 4) The bartenders will provide table service. Food and drink can not be picked up at the bar.
- 5) Food and dripk can only be consumed while seated at a table.
- 6) When you are done leave the dirty glassware on the table and flip over the indicator card so the red side is showing.


